



## **PURCHASE CONTRACT**

**As a Breeder TNT Kennels primary goal is to produce dogs which are going to better the breed. TNT Kennels goal, intention and commitment is to produce only quality breedable animals free of genetic defects. Dogs that we will place in homes, where they will receive excellent physical, mental, and loving care, and WILL NOT be abused in any way. TNT Kennels will screen buyers interested in the dog and then determine if it is in the best of interest for the animal. TNT Kennels will then determine if the animal and interested buyer are a good match for success.**

### **The Breeders guarantees as follows:**

1. To be in good physical condition for the first 72 hours after time of delivery. A Certificate of Health will be issued by the Breeder's Veterinarian upon delivery of the puppy. The Purchaser is required to have the animal examined by a licensed Veterinarian within 72 hours after delivery of the animal for a complete physical condition. TNT Kennels must be informed immediately of this examination. If a veterinarian finds the puppy to have a serious physical condition the seller will replace the puppy with another puppy of comparable quality. The seller will instruct and reserve the right to a second veterinarian opinion at the expense of the seller. If the puppy is not examined by a veterinarian within 72 hours after delivery time, the above guarantees are no longer in effect. All of our dogs go through a total health physical performed by our veterinarian just before each breeding takes place and the dogs are only bred if both are found to be 100% healthy.
2. The puppy will be immunized by the Breeder for the common canine diseases as appropriate for the age of the animal. The pup is up to date on all vaccines and wormings. Vaccination records will be provided. The purchaser is responsible

for all subsequent vaccinations. Failure to properly vaccinate the animal will render this contract void. Proof of vaccination may be required by the Breeder.

3. TNT's goal is to produce healthy, long living family pets and are unable to prevent problems that may arise in the future. However, we do not know of the conditions from prior litters. To be free of any inheritable disease that may cause death or serious impairment of vital functions in the puppy. If such an inheritable disease is documented by a veterinarian and presented to the seller with sufficient supporting evidence, the buyer will be entitled to a replacement puppy of comparable quality from that litter or the next litter available.
4. In the event that the animal is deceased, the Breeder requires that a complete autopsy be performed to ascertain the cause of death and documentation be forwarded to the Breeder's veterinarian. Before euthanasia is administered, TNT Kennels must be consulted or this contract is void.
5. Lifetime Guarantee Against Dysplasia – If, at any time during the life of a TNT Kennels Alapaha, he/she is found crippled from dysplasia, return him/her to the kennel, along with the ABBA papers and we will replace the dog at no charge. (This guarantee only applies to dogs that were X-rayed by the age of two years either OFA or PennHip. If there is any evidence of trauma or injury this contract is void.
6. Lifetime Parvo Virus Guarantee – If your TNT Kennels Alapaha, dies from Parvo virus, return the ABBA papers along with laboratory verification and we will replace him/her at no charge. The guidelines for Parvo boosters are outlined in the puppies vet records supplied to the new owner at the time of purchase.
7. The puppy has been raised and socialized to maximize the potential of the temperament, to the best of the breeder's ability. The buyer understands and agrees that further instruction, obedience classes, and efforts must be made to ensure the continued development of proper behavior.
8. Money-Back Guarantee- A refund of One-Thousand dollars U.S. will be refunded if the Alapaha dog purchased from TNT Kennels receives any top show awards Ring or title or a gold metal. You may be eligible for a 100% refund of the purchase price.
